## Coast Guard Report- Capt. Tony Ceraolo

- Advised of a sunken barge in the San Joaquin Deep Water Channel. A Safety Zone has been established around the vessel which was deemed a hazard to navigation. COTP permission is required to transit the area.
- Advised of recent infrastructure issues affecting USCG YBI operations. Power outages and failure of the emergency backup generator caused temporary loss of telephone and communication ability. Cal OES provided cell phones during the outage. Work to fix the problems is ongoing.

- Announced that USCG Deep Draft Vessel Industry Day is on April 25<sup>th</sup> at CGI.
- Advised of the recent Epicenter 2018 summit in San Francisco. The event focused on earthquake planning and disaster recovery.
- LCDR Rebecca Deakin read from the March- 2018 Prevention/Response Report (attached).
- Jim McGrath asked for information on the widely publicized vessel squatting in Aquatic Park. LCDR Deakin advised that the USCG does not have jurisdiction but is monitoring the situation. Aaron Golbus advised that the vessel has been brought to the Port of San Francisco after breaking its mooring but will most likely be allowed to anchor-out. The legal process is ongoing and sanitation is a concern. Jim McGrath commented on anchor-out issues including obstruction to swimming and recreation.

### **Army Corps of Engineers Report- MJR Kevin McCormick**

- Advised that permanent removal of the sunken barge in San Joaquin Channel will be contracted. Work will take place as fast as possible and updates provided. The contract is expected to be awarded by late June. CDR Stockwell, USCG, advised that the barge was empty and does not pose an environmental risk.
- Read from the US Army Corps of Engineers, San Francisco District Report (attached). Debris removal numbers were above average.

## **SIGNIFICANT PORT SAFETY AND SECURITY CASES (MAR 2018)**

### **MARINE CASUALTIES**

**Loss of Steering (16Mar18):** A U.S. flag towing vessel experienced a loss of steering while approaching a foreign flag container ship in Richmond Inner Harbor. U.S. vessel switched to secondary steering and returned to primary steering regaining ability. Case closed.

**Loss of propulsion (18Mar18):** A foreign flag bulk carrier experienced a loss of astern propulsion while attempting to anchor in Anchorage 9, San Francisco Bay. A COTP order was issued requiring the vessel to remain at Anchorage 9 to effect repairs prior to departure. LOP was attributed to fuel switching. Class and Coast Guard witnessed satisfactory operation of the vessel's main propulsion and associated systems. The COTP order was lifted. Case closed.

**Equipment Failure (20Mar18):** A foreign flag tank vessel experienced a hydraulic oil leak from the stern tube while in port in West Sacramento. A COTP order was issued requiring the vessel to remain at berth until repairs were completed. Vessel rectified the hydraulic oil leak by adjusting vessel's ballast condition to increase head pressure on stern tube seals. Class attended the vessel. The COTP order was lifted. Case closed.

**Equipment Failure (21Mar18):** A foreign flag tank vessel experienced a loss of the remote engine order on the bridge while transiting from West Sacramento to Anchorage 9. A COTP Order was issued requiring the vessel to remain in Anchorage 9 until repairs were complete. Vessel made satisfactory permanent repairs for main engine controls. Class and Coast Guard witnessed operational test of main engine from pilot house and engine control room, and deemed all operational tests satisfactory. The COTP order was lifted. Case closed.

**Reduction in Propulsion (22Mar18):** A U.S. flag small passenger vessel experienced a reduction in propulsion while underway with passengers. The crew shut down the engine to check the alarm and found a faulty sensor. Vessel returned to pier and replaced faulty sensor. Case closed.

**Equipment Failure (25Mar18):** A foreign flag tank vessel experienced a loss of the remote engine order on the bridge while departing from Anchorage 9. Permanent repairs were scheduled to be completed at the next port of call. A COTP order amendment was issued requiring a two tug escort from Anchorage 9 to Mile Rocks. The vessel departed Sector San Francisco COTP zone and the COTP Order was lifted. Case closed.

**Allision (25Mar18):** A foreign flag bulk carrier allided with a Pier while underway to Anchorage 9. Coast Guard attended the vessel and observed minimal damage to the vessel's hull; extensive damage was caused to the pier. Case pends.

### **GENERAL SAFETY CASES**

**Rule 9 Violation, (05Mar18):** A foreign flag bulk carrier took action to avoid collision with a recreational sailing vessel while transiting in the vicinity of San Pablo Bay, Buoy #16. The pilot submitted appropriate forms to the Coast Guard. Case pends.

**Rule 9 Violation (16Mar18):** A foreign flag container vessel encountered a U.S. flag recreational sailing vessel on approach to Middle Harbor while transiting inbound to Oakland. The pilot on board the container vessel made appropriate action to contact the vessel with no response and altered maneuvers to avoid collision. Case pends.

**Safety Zone, Barge by Blackslough Landing (22 MAR 18):** A submerged and adrift barge was reported in the San Joaquin Deep Water Shipping Channel. USCG Sector San Francisco initiated a Safety Zone 200 yards around the barge to restrict vessel traffic from transiting the San Joaquin Deep Water Shipping Channel in the vicinity of the barge, which was also deemed a hazard to navigation. The barge has since been re-secured to the embankment but continues to be unstable and partially submerged. Due to the instability of the barge, an amended Safety Zone with a radius of 90 yards remains in effect. Case pends.

### **SIGNIFICANT INCIDENT MANAGEMENT DIVISION CASES**

**Letter of Warning, (20MAR18):** A Foreign flag vessel discharged an unknown amount of oil from their stern tube into the barge canal in Stockton. A LOW was issued to the vessel. Case closed.

**Letter of Warning, (21MAR18):** A U.S. flag small passenger vessel discharged 20 gallons of lube oil while transiting from San Francisco to Vallejo. A LOW was issued to the company. Case closed.

**1. CORPS O&M DREDGING PROGRAM**

The following report covers the upcoming FY 2018 dredging program for San Francisco Bay. This program is subject to change based on a number of variables including final FY 2018 appropriations and Corps Work Plan. Please refer to the Local Notice to Mariner for details of dredge operations.

**FY 2018 DREDGING**

- a. **SF Main Ship Channel** – Estimated start mid-May 2018, estimated completion early June 2018, by contracted hopper.
- b. **Richmond Inner Harbor** –FY 18 dredging cycle estimated to commence early August 2018 with completion in November. Work will be contracted clamshell.
- c. **Richmond Outer Harbor (and Richmond Long Wharf)** –In alignment with last year’s proposal to alternate Hopper dredging, planned dredging for Richmond Outer will proceed with Essayons.
- d. **Oakland Harbor** – 2017 dredge cycle initiated in mid-August 2017. Significantly larger than expected volumes are requiring additional dredging. Initial estimates indicate approximately 1000kcy resulting in likely need to continue dredging through March 2018 to complete the 2017 dredge cycle. 2018 dredge cycle has a planned start of early August with planned completion in November.
- e. **Redwood City Harbor** – 2018 work plan funding will determine award and quantities.
- f. **San Pablo Bay (Pinole Shoal)** –In alignment with last year’s proposal to alternate Gov’t Hopper dredging Pinole will be deferred in 2018.
- g. **Suisun Bay Channel (and New York Slough)** –2018 Clamshell award is expected to initiate dredging in late August and to complete in late October.



**2. DEBRIS REMOVAL** – Debris removal for March 2018 was 83.5 tons. Raccoon: 20 tons; Dillard: 46.5 tons; other boats: 17 tons, including 4 abandoned vessels. Average for March from 2008 to 2017 is 71.5 tons (Range: 11-231.5 tons).

## 5. OTHER WORK

**San Francisco Bay to Stockton** – The study is now being conducted by the Wilmington District to more efficiently match the study with available resources. Funding was allocated in the FY17 work plan. The Tentatively Selected Plan (TSP) milestone for Phase I (Western Reach) of the project was held on 29 June 2016 utilizing FY14 carryover funds. The recommended plan is to deepen the Phase I reach of the project from a depth of -35 feet to -38 feet MLLW. The final report is scheduled to be approved in February 2019. Additional funding will be dependent upon FY18 work plan funding.

**OAKLAND** » In his first voyage as a deck cadet, 25-year-old Manual Morales has yet to step on U.S. soil.

The crewman on the MSC Athos, a Greek container vessel, doesn't have a visa that allows him shore leave, so he's spent the majority of his time at ports up and down the West Coast on board his ship. Not that there is much time to leave, even if he could. Cargo vessels typically stop for a day or less, and crew members usually have only a few hours to spare.

As automation grows in the maritime industry, crews are getting smaller, even as the vessels are

getting larger, and ships are spending less time at port — a trend that tends to increase the social isolation of their crews, who may go months without
