Re: Letter of Understanding to participate in the 2023 Protecting Blue Whales and Blue Skies Program

Shipping Line	agrees to participate in the
2023 program.	
In order to participate, Shipping Line	agrees to
the following:	

- 1) Identify all eligible vessels (i.e., <u>container ships</u>, <u>car carriers (Ro-Ros)</u>, <u>bulk and general cargo vessels</u>, <u>and tankers</u>) in your company fleet that may transit within the designated Vessel Speed Reduction (VSR) Zones (refer to maps of 2023 VSR Zones in Attachment A) from **May 1 December 15, 2023.**
- 2) Understand that this incentive program is strictly voluntary and that only companies whose fleets travel 35% or more of the distance traveled in VSR zones at 10 knots or less are eligible for participation in and recognition from the 2023 program. The award level and public recognition that a particular company will receive will be based on the percent distance traveled at 10 knots or less. No financial awards will be offered in the 2023 program.

Below are the 2023 award tiers:

Blue Sky: 35% or more of distance traveled in VSR zones at 10 knots or less Gold: 60% or more of distance traveled in VSR zones at 10 knots or less Sapphire: 85% or more of distance traveled in VSR zones at 10 knots or less

- 3) Understand that the average speed of a transit through an entire VSR Zone must not exceed 12 knots to earn credit for distance traveled at 10 knots or less. Also, any nautical miles transited by participating vessels within the Area to Be Avoided (ATBA) in the southern California region will not be counted towards a company's distance traveled at 10 knots or less.
- 4) Allow for participation in public recognition campaigns all shipping lines that achieve at least 35% of distance traveled in the VSR Zones at 10 knots or less will be recognized for their participation through various media, advertising, news releases, announcements, and award events. Participation includes use of company name and logo in program promotional material, as well as the option to provide quotes for press releases and other material.

- 5) Understand and agree that decisions concerning safe navigation and maneuvering of participating vessels remain entirely with ship masters and crew. The Protecting Blue Whales and Blue Skies partners are not liable for any loss, damage, or harm resulting from participation in this incentive program.
- 6) Seek opportunities to highlight, as appropriate, the Protecting Blue Whales and Blue Skies Program in communications with customers and in corporate sustainability reports.

Join our 2023 Vessel Speed Reduction (VSR) Program in the San Francisco and Monterey Bay and Southern California regions

Fleet Approach

Award levels and incentives will be awarded to shipping companies based on percent of distance traveled by all of their vessels through the VSR zones (see maps to the right) at 10 knots or less from May 1 - December 15, 2023. For any distance at 10 knots to qualify for the VSR incentive program, the average speed through the VSR zone for the vessel's transit must be 12 knots or less.

Program participants will receive recognition for their participation, and we will work with successful shipping companies on a positive public relations campaign to draw public awareness to the VSR program and your company's participation.
